1. The Interested Agency/Person should quote their rate in their letter pad or in a plain paper without cutting & over writing with their signature, contact address & phone number. Quotation/Tender shall not be accepted if there is any cutting/ over writing.
2. The vehicle has to be purchased on "as is where is basis". NCA will not incur any further expenditure on the above vehicles.
3. EMD as mentioned above has to be deposited in the form of demand draft of any scheduled Bank drawn in F/o Narmada Control Authority, Indore failing which tender will not be accepted.

4. The highest rate quoted by the agency/person for vehicle will be considered as successful bid
5. The successful bidder/Tenderer has to deposit the quoted(Tendered) amount within 10 days from the date of issue of acceptance letter by Narmada Control Authority, New Delhi in the form of Demand draft/pay order of any scheduled bank drawn in F/o Narmada Control Authority, Indore.
6. If the agency/person does not deposit the tendered amount within stipulated period as mentioned above, then his/their EMD will be forfeited.
7. The vehicle has to be lifted/driven out by the agency/person from the office of NCA at his/their own cost, within 10 days after settlement of payment and showing the paper of insurance / undertaking to the effect in case of any accident of the vehicles before transferring of registration in the name of agency/person, then bidder will be responsible and NCA will have no liabilities due to any mishappening from auctioned vehicles.
8. After sale of vehicle, it will be the responsibility of purchaser to get the registration no. transferred in bidder's name. Without change of registration No. in the name of purchaser, the agency/person will not be entitled to run the vehicle.
